
## **Westbury Civic Club Office Has Moved!**

## President's Message

The New Year always seems to begin with a vengeance. This year was no exception! This January included moving decades worth of documents and materials belonging to the Westbury Civic Club (WCC) into our new office space a few doors away from our old location. We are now are in Suite 100. When you look at what happened to other commercial properties in Westbury versus what has happened at the Westbury Professional Building where we office, you can see what a difference ownership makes. I have to applaud Don and Helen Bryan on their pride of ownership. Don was a long time board member of both the WAIC and WCC and we thank him for his years of service as a volunteer, as a resident of Westbury, and as a business owner in Westbury.

I am very excited about our new space as it will allow us to be more effective in all the areas as we improve the appearance of the neighborhood and promote the civic, cultural, educational and general welfare of the residents here. We have touched on all those categories in January! Arbor Day was celebrated in late January as we worked to improve both Westbury Park and the Willow Waterhole Greenway. On the municipal front, the mayor was the guest at the SWHouston 2000 breakfast and the WCC attended a mayoral press conference on flooding and a City Council public hearing on the civility ordinance. Check out pages 7, 12 and 15.

On the Education front, there are several articles in this *Crier*. We congratulate our HISD Board Trustee, Wanda Adams, on

her election as President of the HISD Board. In February, Westbury High School will hold a community meeting to unveil where and how YOUR \$40 million of HISD 2012 Bond money will be spent. Please make an effort to attend this meeting on February 8 at 6:30PM.

Let's talk about the power of showing up. If we can fill the lecture hall with people, then we will show HISD that Westbury cares and that we are watching. HISD promised that they would expand the Westbury High School campus as part of the 2012 Bond, the board voted in open session to acquire the properties, and then the board reneged on that promise and spent the funds elsewhere. Our unhappiness with HISD's untruthfulness remains unabated, and we intend to work with the new superintendent to right those wrongs. But we need YOU! Please answer the call and attend a meeting if we ask. We will get a bus, if we need one, to go to an HISD board meeting. Right now, I just need you at Westbury High School on February 8!

While you are marking your calendars, please mark March 9. This is the District K Capital Improvement Projects (CIP) City meeting where we advocate for big ticket items like new streets and new drainage. Do you want new streets and new drainage? Do you want less flooding? Then YOU need to show up on March 9! It cannot just continue to be the same handful of people who stand for Westbury residents on a regular basis. Yes, I am happy to do it, as are the others who serve on the WCC and WAIC boards.

But sometimes we need YOU. Won't you give a few hours of your time to just show up and be seen? Wouldn't new streets, new drainage, and less flooding be wonderful?

As for flooding, you will read on page 13 that the January 18 rain event which brought over 5 inches to Westbury in two hours caused NO structural flooding. Isn't that amazing? We are so appreciative of the City and the County for the work that has been done in the last year.

The 2017 Willow Waterhole Music Fest is going to be the best one yet and will include a real art show. The Company On Stage, Westbury's beloved theater, has found a new home. It, too, has sponsorship needs and you can read all about it on page 10. And if that isn't enough culture, the Westbury Community Garden was in the audience at the Great Day Houston television show in January!

And, last but not least, a big thank you to all of you who paid the dues and even contributed extra to the Westbury Area Patrol. We paid our way in 2016 without borrowing on the WAP savings! This is very good news. The 2017 dues statements are delayed due to the office move and will be mailed out in February. If you want to pay your voluntary dues with the form on page 17, please do so.

Looking forward to working together to make Westbury the best that it can be.



# Platting Standards Committee

Cindy Chapman is the representative from Westbury and District K on the city "Platting Standards Committee". The Planning Commission on Platting Standards will consider issues and potential revisions to Chapter 42 platting standards and related ordinance changes. This committee of the Houston Planning Commission is comprised of neighborhood, development and other technical representatives. The committee will consider and make recommendations on potential changes to the platting standards in Chapter 42. They will consider and make recommendations on establishing a predictable process for regularly reviewing and revising development codes administered by the Planning and Development Department.

#### Mayor Featured at SWHouston2000 Breakfast

The nonprofit SWHouston2000 is an advocacy group on behalf of the greater southwest area of Houston. Mayor Sylvester Turner was the featured speaker for the January 2017 Breakfast and spoke in front of an audience of about 200 at an event held at Houston Baptist University. As usual, the Westbury Civic Club

sponsored a table for the Westbury Super Neighborhood.

Mayor Turner noted that Houston is the most diverse city in the USA and has the 4<sup>th</sup> largest population. After a year in office he noted that more than 40,000 potholes have been fixed and 97% of potholes are now repaired within 24 hours. The process has been streamlined and now Public Works is able to work on more concrete panel replacements. Drainage and flooding issues are moving forward. The city is working with the state Water Development Board, Harris County, and the federal government to make faster progress to complete



Project Brays. Also, the city will start attacking small drainage projects the way they did potholes. The city has already identified at least 60 local drainage projects. Each year they will select 2 local drainage projects in each council district (22 per year) to work on.

Regarding Public Safety and Pension Reform, Mayor Turner noted that we are short 600 police officers, so he reassigned 375 desk jobs to patrol duties. Some officers may retire as a result of pension reforms. The city has \$7.9 billion in unfunded pension obligations so it is important to create a pension plan that is reliable, sustainable, and dependable that is "fair to everyone". A plan is supported by the pension holders, city council, and the Houston business community that will be filed with the state legislature for approval.

The breakfast program also included a presentation by students from Westbury High School who have received a Leadership Grant from Cheniere Energy.

The 2017 Westbury Civic Club (WCC) budget was approved at the January 2017 board meeting.

Mandatory Assessments for 2017: Residents of Parkwest 1 and Parkwest 2, who bought their homes after 1993 & 1994, have mandatory assessments. Mandatory Assessments are adjusted annually for inflation. Mandatory assessments did not increase and remain at \$233.50 for 2017.

**Westbury Civic Club Dues:** The WCC Dues (encompassing all operations, programs, and services including greenspace, except patrol services) will remain at \$50. The 2017 budget includes increased funding for supplies due to our move to a new office space and includes some additional payroll for the possibility of a second part-time employee.

Westbury Area Patrol (WAP): The requested dues for the Westbury Area Patrol remain at \$285. This amount is similar to what is paid by residents of Maplewood N/S and Meyerland for their mandatory patrol assessments. The board will investigate additional fundraisers to support the WAP program. The good news is that in 2016, all contributions received covered the cost of the WAP patrol!

**Voluntary Dues TOTAL:** The total sum of Westbury Civic Club Dues plus the Westbury Area Patrol is \$335.

**Other Fees**: Our other fees remain the same as 2016: Transfer fees \$125. Refinance fees \$75. Resale Certificate is \$100, while a rush Resale Certificate request will be \$150. These fees are charged for the research and paperwork that is needed to fulfill the requests.

**Special thanks:** We thank all of you who paid monies toward the WAP Patrol this year. The cost of the WAP contract of \$316,925 was covered in full this year! That is \$233,547 in payments from the voluntary sections plus \$61,162 from the mandatory assessments and \$22,216 from residents who sent in special contributions. Several residents made \$1,000 payments to the WAP patrol. Together we do make Westbury safer for everyone! Please see page 14 for additional security information.

# Recycling Mess at Church Westbury Residents Help Church

Westbury United Methodist Church (WUMC) graciously allows its property to host paper recycling bins and a glass recycling bin.

GLASS- only bottles and jars should be placed in the bins. No lids, tops, or corks, etc. When the City first made the glass recycling bins available and WUMC was chosen as the site, we made an appeal to recyclers to please help keep the area free of broken glass and trash. Recently people have left items outside the bin such as paint cans and mirrors. Please do not leave anything outside the bins.

WUMC agreed to be the site for glass recycling in the spirit of community service. They do not receive funds from glass recycling.

Paper and cardboard bins - Please flatten boxes before dropping them in the bins.

DO NOT leave anything stacked outside the bins. The paper bins are sometimes the scene of illegal dumping by folks who mistakenly think recycling means dumping a bunch of boxes and household trash on the ground around the bins.

The recycling companies don't police the area. A truck comes and picks up the containers, empties them and drives away. The driver may never even leave the cab. Anything left on the ground is left to the pastor of this church to pick up.

As Christmas Eve approached, the site was really a trashy mess and, thanks to several area residents, the area was spic and span before Christmas services were held. A big thank you to the Strom family, who cleaned up the area on Dec. 27, and to Steve Goldberg, who

cleaned up on January 10.

Illegal trash dumping is why recycle bins are no longer available at Westbury Square, the Platou Center and Willow Meadows Baptist Church. If you want to be able to recycle paper and glass we need to help keep this area clean.

# Remodeling your home? Adding On? Do you know the deed restrictions on your lot?

Every residential lot in the Westbury/ Parkwest subdivisions has restrictions placed upon the land through its deed of trust. It does not matter whether you have mandatory assessments or voluntary dues, every lot has valid and active deed restrictions.

In Parkwest 2, NO building or decorative appurtenances shall be erected, placed or altered on any building plot in the subdivision until the building plans, specifications and plot plan showing the location of such building or decorative appurtenances have been approved in writing. ALL OF PARKWEST 2 MUST SUBMIT PLANS TO THE WCC OFFICE.

Westbury 2, Westbury 3, and Westbury 5 have a 25-foot rear setback for the main structure. Every section has a minimum percentage of brick requirement. Every lot has a front building set back line in front of which you cannot build. Every lot has side setback lines. Corner homes have different setbacks than middle lots. The setbacks are measured from the property lines as documented on the property survey and the recorded plat.

The Westbury Civic Club can look over your proposed plans for free before you start construction. We want to avoid deed restriction violations before they happen. We want you to find out about possible violations before it costs you time and money. Several homeowners in the past couple years have had to tear down and/or modify their construction due to deed restriction violations.

**The City of Houston does not review deed restrictions when issuing permits.** They require a signed affidavit acknowledging that the plans comply with your deed restrictions. This holds YOU, the homeowner, accountable for knowing and complying with your deed restrictions. All deed restrictions are available online at westburycrier.com and in the WCC office.

## I AM Company On Stage Fundraiser



## Only RAIN in the Drain

## Only RAIN in the DRAIN!

As it rains in Westbury, water begins to build up along the street edges and gutters. It's here that it begins its long journey to the sea. The first destination on this journey is to the storm drain inlet on your street. Clearing the path to the storm drains is essential. Once it reaches the inlet it flows into the storm drains and eventually ends up in one of the drainage ditches or Willow Waterhole Bayou then off to Brays Bayou, then the Houston Ship Channel and ultimately to the Gulf of Mexico.

It's very important that you prevent debris from blocking the flow of the water to the storm drain inlet. It is vital to keep the water flowing in the storm drain pipes under the streets that we don't see.

Solid debris takes up space in the storm drain pipes making them less effective in transporting storm water to our ditches and bayous. Small sticks, leaves, newspapers, and other trash become wrapped together and could clog and slow the draining on your street. Our storm drains in Westbury are old. They are original to the neighborhood and should be treated with care.

Only rain in the drain!!! Our trees are old and

have huge roots that are bound to have popped through, combine this with leaves and other debris, and water just can't flow at the rate it should. If the rain is falling very rapidly (as it has

on the streets needs to flow as fast as it can to the bayous.

many times in the past several years), our water

Here are some things you can do to help.

- Sweep & BAG your leaves out of the street.
- ⇒ Ask your yard crew to NOT blow the leaves and grass clippings down the street or into the storm drains.
- ⇒ Clean the storm drain inlet in front of your home (if you have one)
- ⇒ Pick up the newspapers that are thrown in your yard. Even if you don't want to read it, pick it up & throw it in the recycling can.
- ⇒ Street gutters are city property. If your neighbor doesn't sweep, do it yourself. It's worth protecting your own home with a little street sweeping.

Talk a walk around your block or just down the street and look around. What do you see in the

streets... cigarette butts, cans, food wrappers, plastic bags, paper and especially news papers that are not picked up, leaves, yard clippings and animal feces.




Residents clearing debris along Landsdowne and the Willow Waterhole Bayou during Tax Day 2016 Floods.

## **Project Brays Funding Solution**

## Agreement Reached to Fast-Track Brays Bayou Flood Relief

On January 24, Houston Mayor Sylvester Turner and Harris County Judge Ed Emmett announced an agreement involving the city, county, state, and federal government, which will fast-track the long-awaited flood relief for Houston families in the Brays Bayou watershed.

According to a press release from CM Ellen Cohen's office, "The new intergovernmental funding agreement seeks to solve cash-flow challenges that have delayed the Harris County Flood Control District's (HCFCD) ability to complete Project Brays, a series of planned improvements including channel-widening, bridge replacements, and new stormwater detention basins."

At the Mayor's behest to expedite these needed drainage improvements, the Texas Water Development Board (TWDB) has agreed to loan the City of Houston \$46 million. After

approval by City Council, the City will then advance the funding to the HCFCD to assist in construction to improve Brays Bayou. Once the project is complete, then HCFCD will be reimbursed by the federal government, and will in turn repay the loan to the City of Houston.

Attending the press conference on the banks of Brays Bayou were WCC Office Manager, Jennifer Edmondson, and

Westbury Super Neighborhood Co-President, Cindy Chapman. They were able to thank the City for the local drainage project to repair four collapsed outfall drains along the Willow Waterhole Bayou and to advocate for more work on other collapsed outfalls to the west. They also expressed concerns regarding stormwater design standards used when new developments are built, noting that other nearby counties have more stringent requirements.

At the City Council meeting on January 25th, the city council passed a resolution to authorize the submission of a loan application to the Texas Water Development Board (Clean Water State revolving fund program).

## Major Jan. 18 Rain Event: How Did Westbury Fare?

On Wed., January 18, the City of Houston experienced another major rain event. As we go to print, no Westbury homes reported any structural flooding during this rain event. Westbury is a large neighborhood and flooding occurs in different parts for different reasons. What was different this time that helped Westbury homes?

Gary Zika of Project Brays reported that even though Project Brays is not yet complete, it is further along than it was since we experienced water in some of our homes during the 2016 Tax Day Flood. Project Brays helps all of Westbury because it will help Brays Bayou stay within its banks.

The City did a local drainage project to repair four collapsed outfalls on the WWB. This project helped residents east of Hillcroft. One resident on Cartagena reported "the street drained much better than in the past. It seems the repair work helped out." Another resident on Ludington, who has experienced

flooding multiple times, had NO water in his home.

Harris County commissioner's Court approved the de-silting of their drainage ditches in 2015 and that work (with the exception of some ongoing work on the southern end of the Braewick ditch) is now complete. This work benefitted all areas of Westbury.

Less rain fell in the whole Brays watershed and Brays Bayou did not overflow.

The Willowbend asphalting project also included curbs and gutters and repairs to a drainage line. Two residents on Willowbend, one of whom who had experienced structural flooding in the past, both reported that the water drained more quickly.

Our streets are designed to hold water and we had serious STREET flooding. It is important that unless you absolutely have to be somewhere, don't drive through

flooded Westbury streets. Gawkers in big trucks have pushed water into more than one Westbury house in the past. Other drivers have seriously rutted esplanades and yards when they drive off road to avoid high water.

The City's Capital Improvement Plan (CIP) meetings are coming up on March 9 and we will continue to STRONGLY ADVOCATE for the new streets and storm drainage that Westbury so desperately needs.

If you experienced water entering your home on Jan 18 or if water came perilously close to your home, please email wccpresident@westburycrier.com. Please call 311 to report if the following things occurred on Jan. 18: sewage backup in your house; sewer manhole had storm water bubbling out of it; water came into your home or your street was slow to drain.

Please mark your calendar for March 9 so that you can attend the CIP meeting that evening.

## **Crime Prevention Tips**

The WCC Security Director, working with a committee and law enforcement, has a list of tips to share. Most of these have been shared in past Criers, but they bear repeating.

- Know your neighbors.
- Be aware of your surroundings.
- Put the constable number (281) 463-6666 in your cell phone. Set it as A Constable or set it as a Quick Dial. At home, tape the number to your phone.
- If you see something that doesn't look right, call the Constables. It may not be anything, but there is a car parked in my neighbor's driveway, and it's backed up to the garage, and you don't recognize them. Call Pct 5 Constables!
- Put your car keys by your bed on the nightstand. If you hear something that sounds out of the ordinary, press the car alarm on your remote control on your keys. Then call the police/constables.
- Install good outdoor lighting in the front and back yard.
  Consider installing different types of lights: Motion lights,
  lights that come on at dusk and go off at dawn, or always on.
  Lighting tends to discourage thieves.
- Lock your garage doors, and lock your back gate. If you don't have a back gate install one. Put a lock on it, and keep it locked.
- Get an alarm system (monitored or unmonitored). Monitoring is normally \$20-25/month on a month to month or contract basis. If you pay the annual dues for the Westbury Area Patrol service, then Pct. 5 recommends that you put the constable number as the first number dialed. Put yourself second and HPD third. However, if you do not pay for the WAP patrol, then HPD should be called. Be sure that you have an unexpired alarm permit issued by the City of Houston.
- Park your car in the garage. If you can't, don't leave anything visible in the car.
- Get a dog. Barking dogs can discourage crime.

## **Civility Ordinance Status**

# **Greater S. Post Oak / W. Bellfort Civility Ordinance**

A public hearing was held at City Hall in Council Chambers on January 25 as part of the petition process for the creation of the South Post Oak/ West Bellfort civility zone. The City has a process where neighborhoods/areas may petition the city to come under the civility ordinance, which prohibits laying or sleeping on the sidewalk between the hours of 7AM and 11PM.

This grass roots campaign started over two years ago. Aggressive panhandling in this area had become a pervasive problem. And as it went unchecked it just became worse and worse. Trash, public urination, and blatant drug use were visually disturbing. But it was also a real problem for the nearby businesses as people began to view the areas as unsafe and began to avoid the area. People couldn't access the pedestrian right of ways without fear. People who use public transportation were impacted, kids who used to walk home from school were impacted, and adults who used to walk to the grocery store or to the fast food places were impacted. The pedestrian walkways were impassable. Even in our cars they would scream at us and sometimes bang on our cars.

Residents from nearby neighborhoods went to the District K council member and to the Houston Police department. Marilyn Brown, executive director of houstonhomeless.org spoke at a Westbury Super Neighborhood meeting. We looked for answers and solutions.



Three neighborhoods: Willow Meadows, Westbury and Meyerland worked up a one page public service campaign asking people not to give to the panhandlers. We heard Mayor Turner tell us to just say no to the panhandlers. Giving money may make one feel good, but it is not helping the individuals out working the streets.

CM Green hosted an important meeting with all the stakeholders: neighborhoods, TxDot, HPD, Metro, and more. Petitioning for this civility zone was seen as another tool in our toolbox. Dozens of people worked to collect signatures and the coalition met the criteria of 20% of the landowners by square footage and 100 signatures. Over 800 signatures were collected.

Captain Anthony of the Southwest Patrol Division of HPD made a crime presentation to council. Steven Paletz, of Willow Meadows, and Becky Edmondson, of Westbury, spoke on behalf of the civility zone during the public comment period. The next step will be for the petition to be put on the Council agenda and have the Council vote to approve it.



## Flood Mitigation and Greenspace: A Three Part Series

This is the first in a series of three articles about how the Brays Bayou Association, the Willow Waterhole Project (March) and the Willow Waterhole Greenspace Conservancy (April) came to be and how they have impacted life in Westbury.

# Part One: Brays Bayou Association

Each month the Crier lists the meeting information of the Brays Bayou Association (BBA), which takes place the third Monday of each month. Their purpose is to reduce the risk of flooding in the Brays Bayou watershed, one of the 22 watersheds in Harris County. Westbury is located in the Brays Bayou watershed, since Willow Waterhole Bayou is a tributary of Brays Bayou.

The BBA was formed in 1984, after Hurricane Alicia hit in August 1983, followed in September by a major thunderstorm with 9 inches of rain, which resulted in extensive flooding in the area. (Similar to the Memorial Day flood of 2015) About 1,800 homes were flooded, many in Meyerland. To fund the organization, Bob Marshall of the Meyerland Community raised about \$60,000, largely from Meyerland residents. Ann Lee of Maplewood South/North was the first president. There was a lot of fingerpointing about who was responsible for the 1983 flooding.

The Harris County Flood Control District (HCFCD) and the U.S. Army Corps of Engineers were soon in the organization's sights. The BBA funded a study by Professor Phil Bedient, and BBA and several developers co-funded an engineering study by Pate Engineers.

In the late 1980s, Commissioner's Court replaced HCFCD Director Jim Green with Art Storey. Harris County Commissioner's Court proposed a countywide bond issue for a variety of county needs, among them flood control. The BBA considered the proposed figure for the flood control component insufficient and went to Commissioner's Court and suggested \$250 million would be more appropriate. The Court agreed and the BBA said it would campaign in support of the bond issue. BBA sponsored a large public meeting where attendance was estimated at 750. The bond issue passed with about 62 percent approval.

In the early '90s, HCFCD contracted a study on the Brays Watershed to determine the best strategy to reduce flooding risk for the upper part of the watershed. At the same time, Ken Bentsen, our area Representative in the U.S. Congress, began to solicit input from HCFCD, BBA and others, concerning issues affecting flooding in the Brays Watershed.

The Water Resources Development Act of 1996 (WRDA 96) included language which permitted a competent local authority such as HCFCD to plan, design, and construct local flood control projects under Corps of Engineers' oversight and monitoring, according to federal rules, regulations and guidelines, and allowed for aesthetic considerations. Then the project could receive federal reimbursement up to about 50 percent. The three Texas projects were

all in Houston; Brays, Greens and Hunting Bayous.

In late 1996, the BBA supported a proposal by Westbury resident, Russell Schexnayder, that a stormwater detention site be constructed adjacent to Willow Waterhole Bayou. The story of the Willow Waterhole project will run in March.

The BBA continues to work closely with HCFCD and the City of Houston on various flood risk-reduction issues. It has worked closely with the

city on changes to Chapter 19 of the Code of Ordinances dealing with flood-prone areas, and other regulatory documentation. The BBA has been establishing links with those involved on issues affecting flooding by inviting speakers to our meetings and staying in contact with groups such as The Park People, Trees for Houston, The Bayou Preservation Association, The Quality of Life Coalition, and the Citizens Environmental Coalition.

The January 2017 BBA meeting was well attended. The speaker was Gary Zika. Project Manager of Project Brays, with an update on Project Brays as well as for the Willow Waterhole (WW) detention project. For the WW detention, new connecting boxes and new overflow weir control structures are the final stages needed to complete the WW project. The connecting boxes will connect the newest ponds to existing ponds (pond 6 to existing pond 4 and pond 1 to existing pond 2) underneath South Willow Drive. Also, larger drainage boxes along the pipeline easement that run through Westbury between Kingfisher and Spellman will go out for bid this first quarter of 2017 and are scheduled to be complete by August of 2018.

The majority of flooding we see in Westbury is from water that is trying to get into the bayou, not from the bayous or ditches overflowing their banks. Enlarging the city's storm drains won't help if the bayous don't have the capacity to take the water. One way to slow down storm water is to build detention ponds that will hold it until the bayous are ready. The BBA has been asking the City of Houston for years to consider buying land for future use as a detention "bank," which would help reduce risk of flooding in the Brays watershed. We need more detention upstream of Westbury (to the west of us) to alleviate flooding from too much water trying to get to Brays Bayou and the Willow Waterhole Bayou.

## Willow Waterhole Conservancy Receives Urban Forestry Grant from the National Football League, Houston Super Bowl Host Committee, and Trees for Houston

WWGC was one of ten environmental organizations awarded \$4,000 Urban Foresty Grant by the NFL and the Houston Super Bowl Host Committee for tree planting projects. Additionally, WWGC was the recipient of 20 mature trees and 80 seedlings from Trees for Houston. The trees were planted on three workdays in January:

- On January 7, scout James Huff led volunteers on his Eagle project to plant 10 trees on the banks of Levitt Lake near Southern Crushed Concrete (see right)
- On January 14, Unitarian Universalist church members were joined by residents of the local community and the Host Committee in planting 80 hickory oak seedlings at two locations – on the eastern bank of Westbury Lake and along an AT&T chain link fence bordering the Greenway on South Willow
- On January 28,, as part of Westbury Arbor Day festivities, WHS Honor Society students and local residents planted 10 more trees at the same site on Levitt Lake.

Bill Burhans, Conservation Director at WWGC, stated: "this assistance provided by the NFL, Host Committee, TFH, and volunteers will go a long way towards improving several areas at the Greenway. The tree plantings will serve as natural screens along the borders with industrial sites. Additionally, the donated monies can be used to purchase mulch, tree stakes, tools, and watering needed for plantings and ongoing maintenance. We are so grateful to these generous organizations and happy that Houston was selected as a Super Bowl city."



This is the new sign placed at the tip of Triangle Lake (the fork in the road at Gasmer/South Willow). There is a new trail on the right hand side along the bank of the lake. These improvements were a result of a grant received in 2013 from the Coastal Impact Assistance Program. The Willow Waterhole Greenspace Conservancy and Houston Parks and Recreation Department were awarded the grant based on conservation and educational programs at the Greenway.

## **Eagle Scout Project at Willow Waterhole**

James Huff (at far right in the photo below) completed his Eagle Scout project on Saturday, January 7, at the Willow Waterhole Greenway. James is a member of Willow Meadows Troop 740 and a student at Westbury High School. The workday started at 8AM with 23 degree temperatures. Despite the cold, many friends, fellow

scouts, and parents assisted James in planting 11 large loblolly pines and bur oaks. Trees and supplies were donated by Trees for Houston and the National Football League as part of a grant received by the Conservancy connected to Super Bowl activities.



Many thanks to volunteers from the Unitarian Universalist Church and the local community for coming out on January 14 to plant 10 new trees, spread mulch and wildflower seeds, and prune many existing trees at Triangle Lake. Trees and materials were donated by Trees for Houston, Verizon, the Houston Host Committee, and the NFL as part of Super Bowl activities.
