# Harris County Bond Election to Reduce Flooding—August 25

On the one year anniversary of Harvey, Harris County will be having a bond election. The proposed bond could be up to \$2.5 billion in flood reduction projects. The County is holding 23 community meetings to receive community input. As of press time, the meeting for Brays Bayou has not been scheduled. It will likely be in July. Stay tuned to our Facebook page, Westbury Houston or our website, www.westburycrier.com.

The bond election will be on August 25, 2018. Early voting will start on August 8. The August *Westbury Crier* will have more information regarding polling locations.

### A Message from the Westbury Civic Club President

Summer is here! There is always a flurry of activity in April and May as there are end of school events and many other events. The summer is usually a slower time. The June WCC meeting was canceled by the board since so many of us were traveling.

I had a lot on my mind as we moved through the Memorial Day and into the Tomato Tasting the following weekend. The Friday before Memorial Day weekend in 2015, the Westbury Civic Club was awarded first place in the Neighborhood of the Year contest by Neighborhoods USA for our work in saving the Westbury Community Garden. It was an incredible feeling, first, to have saved the 7 acres as greenspace and, secondly, to be recognized by this organization. Westbury was also featured as a tour stop destination for conference attendees. The Westbury Crier was 2nd place award for newsletters. It was a great feeling of accomplishment and good time to be in Westbury.

But life has a way of humbling you. Less than 48 hours later, the rain began to fall and we awoke on that Monday morning to more than 300 flooded homes in Westbury. For the last three years, flooding concerns have dominated the landscape with the Memorial Day 2015 flood, then Halloween 2015 flood, 2016 brought the Tax Day flood, and 2017 brought the Hurricane Harvey flood.

The Westbury Civic Club is working with all the involved entities to bring solutions and resources to end repetitive flooding issues along the Willow Waterhole Bayou. This is an ongoing long term process. If you ever read past issues of the Westbury Crier, you will see that the Westbury Civic Club has historically advocated for better drainage along the Willow Waterhole Bayou. Stay tuned for developments and meetings as they occur.

One question asked at a recent workshop was "How do you see this area in twenty years?" In nearby Meyerland, houses are being elevated and others are being razed and replaced by one million dollar plus homes. In Westbury we are seeing some homes being elevated and few being torn down.

In better news, the Westbury Community Garden is thriving. The 5th annual Tomato Tasting was held, as always, the first weekend in June. There was a nice crowd of people and the garden looked wonderful. I am always so thankful for the many gardeners who have taken such good care to grow and protect this incredible asset. That we were able to create this seven acre oasis and then get it protected as green space was quite a feat of accomplishment. The late CM Larry Green was our champion as was David Hawes from the Brays Oaks Management district. We couldn't have done it without the assistance of Mayor Annise Parker, too. They are/were public servants who care about the greater good. I think more people would vote and participate in the political process if they really got to know the people who represent us here. The media paints such a negative picture, sometimes rightfully so, but not every person who serves deserves to be painted with the bad brush.

Our other great social space is the Willow Waterhole Greenspace. You can read about a recent Park Smart meeting on page 20. There are many needs at the park: parking, better accessibility and better security. I had an opportunity to participate in a tour through the park and it is always fun to see people's reactions to this big, beautiful oasis. Our latest visitor said, "Wow, this place should be the next Memorial or Hermann Park." Yes, it should be!

#### **Common Water Safety Rules**

Tragically already this season, 22 kids have drowned in Texas so far in 2018. Last year, 78 kids drowned in Texas. Water is a great way to beat the heat, but summer is also when children are most likely to drown. Drowning is a leading cause of accidental death for kids under the age of five and toddlers are especially at risk. Drowning can happen in almost any amount of water, indoors or outdoors.

- Never leave a child unsupervised around water, inside or outside of the house. It only takes a few minutes for a child to drown.
- Never leave children alone around with water whether it is in a pool, wading pool, drainage ditch, etc.
- ⇒ Constantly watch children who are swimming or playing in water. They need an adult or certified lifeguard watching and within reach.
- ⇒ Secure access to swimming pools. Use fences, self-closing and latching gates, and water surface alarms.
- ⇒ Completely remove pool covers when the pool is in use.
- Store water toys away from the water when not in use so they don't attract a small child.
- ⇒ Don't assume young children will use good judgment and caution around water.
- ⇒ Be ready for emergencies. Keep emergency telephone numbers handy and learn CPR.
- ⇒ Find out if your child's friends or neighbors have home pools.

#### **Pool Safety and Violations**

The summer heat has arrived! We want everyone in Westbury to have a safe summer. Back in 2013, the Westbury Civic Club's Environmental Committee met with the City of Houston's Health and Human Services pool inspectors to discuss swimming pools and safety. The WCC office has received numerous phone calls regarding unmaintained pools. All residential pools must be fenced. The fence must be at least 4 ft. high and in good condition (no gaps over 4 inches) with a self-latching gate. The pool water must be maintained.

Report a violation as soon as possible if:

- There is a house, occupied or unoccupied, with a pool or spa that has not been properly maintained. This can result in green or black water that may breed mosquitoes.
- There are any slats broken or missing from a fence surrounding a pool or a spa. This also includes both vacant and occupied houses.
- If a house or property has any type of outside above-ground pool or spa that is not enclosed by a secure fence.



#### **Brays Bayou Association**

The Brays Bayou Association (BBA) was founded after the Brays Bayou devastating floods in 1983. The organization has been instrumental throughout the years in getting studies and projects.

The BBA meets monthly on the 3rd Monday each month at 7:30 PM at the Gathering Place at 5310 S. Willow Drive.

The topics at the June 2018 meeting were an update on Project Brays and a discussion about the proposed county bond for flood projects by Gary Zika, Project Manager for Project Brays.

#### **Willow Waterhole Basins**

Work is about 75% complete. There has been a delay in installing the new big, box culverts leading from the intersection of Chimney Rock/ West Bellfort back to the Willow Waterhole Bayou because of a natural gas line that needs to be modified in the corridor by a different organization.

#### Flood Risk Reduction Bond Project

The county proposes a \$2.5 Billion bond to pay for projects to reduce flooding risk in Harris County. The election for this bond will occur on August 25, 2018, the one year anniversary of Hurricane Harvey. Gary Zika discussed the proposed projects being considered which impact flood risk in the Brays Bayou watershed. Of particular interest to Westbury is a proposed "Local Project" intended to reduce the water level in the "Fondren Diversion Channel" upstream of Westbury (high water level in this channel overflows through Westbury via the Willow Waterhole Bayou). The proposed project involves "Right-Of-Way Acquisition, Design, and Construction of Channel Conveyance Improvements" on the Fondren Diversion Channel from near Beltway 8 and then as it heads north until it meets Brays Bayou (see map). Detention may be included in the project as mitigation to offset improvements to channel conveyance. There was discussion that the city of Houston is also interested in implementing a project to improve the channel/provide detention in the area of the Fondren Diversion Channel near Willow Waterhole Bayou.

Westbury residents are encouraged to attend an upcoming meeting scheduled to discuss Brays Bayou projects in the proposed bond. This meeting is not yet scheduled, but might be held on July 9. The exact date and time will be posted on social media when it is available.

# **When it Rains**

If you would like to understand Houston's flooding problem, there is a 15 minute film produced back in 1979 that is as timely today as it was 39 years ago. The film is part of the Texas Archive of the Moving Image.



This film, narrated by actor Carle Bensen, presents Houstonians with a comprehensive look at their city's flood control infrastructure, put in place to deal with the heavy rains typical to the area. Due to natural factors such as a flat, low-lying topography and high clay

content in the soil, as well as rapid urbanization, Houston has a history of flooding, and flood control projects, dating back as far as 1908. The film educates viewers about flood control systems in place, discussing strengths and weaknesses of the flood drain, storm sewer, bayou, channel, and pond system. It also recounts the physical and economic damage caused by flooding in the 1970s, the consequence of failure to continue to implement flood control improvements. In the end, the film is a plea to get back to the plan, urging the public to take action by voting on bond and tax allocations for drainage projects, and contacting their public officials to support the issues. # Are you Prepared? No, really. Are you ready?

#### **Basic Preparedness Tips**

- Now where to go. Westbury is not in an evacuation zone, but if your house has flooded before or if you are dependent upon electricity, then you may want to make plans to go elsewhere.
- → Put together a "Grab and Go-Bag": a bag with disaster supply kit (including a flashlight, batteries, cash, first aid supplies, medications, and copies of your critical information if you need to evacuate)
- →If you are not in an area that is advised to evacuate and you decide to stay in your home, i.e. shelter in place, plan for adequate supplies in case you lose power and water for several days and you are not able to leave due to flooding or blocked roads.
- → Make a family emergency communication plan.
- → Subscribe to AlertHouston to receive up to date info.

#### **Preparing Your Home**

- → Hurricane winds can cause trees and branches to fall, so before hurricane season, trim or remove damaged trees and limbs to keep you and your property safe.
- → Secure loose rain gutters and downspouts and clear any clogged areas or debris to prevent water damage to your property.
- → Purchase a portable generator or install a generator for use during power outages. Remember to keep generators and other alternate power/heat sources outside, at least 20 feet away from windows and doors and protected from moisture; and NEVER try to power the house wiring by plugging a generator into a wall outlet.

#### Disabled, or do you have access or functional needs?

→Call 2-1-1 and let them know that you want to register for STEAR (State of Texas Emergency Assistance Registry). Registration is VOLUNTARY. Required information is: Name, address, phone number, and primary language. Additional questions include: Emergency contact information, caregiver information, pets, and transportation assistance for home evacuation, communication barriers, Disability or Functional or Medical Needs. This is for planning not evacuation.

# Knowledge is Power

#### **Weather Wary in Westbury**

Does rain make you nervous? Are you unsure on the weather forecasts? Does listening to the news weather reports make you panic? You are not alone. Houston weather over the past couple years has made us all very wary, if not scared, of storms.

Houston gets rain. The trick is to know where and how much. There are many good websites and apps available that can help guide you before rain events or during them. One good piece of advice is to look for warnings and alerts from the actual source, for example the National Hurricane Center. This is not a complete list but a sampling meant to help guide you and add to your storm preps.

Harris County Flood Warning System - www.harriscountyfws.org
This website is extremely helpful <u>during</u> a rain event. It shows real
time bayou levels and rainfall amounts at gages that have been
installed along the bayous. **Gage 445** is located in Westbury on the
Willow Waterhole Bayou at the Landsdowne bridge. Gage 440 is
located on Brays Bayou at S. Rice. A new tool just introduced to the
website is a Flood Inundation real time map that can help residents
make critical decisions regarding life and property during events. If
you are ever curious about the rainfall amounts and rate, you can
also look up historical data.

#### National Hurricane Center - www.nhc.noaa.gov

If there is a chance of a named storm or there is a current named storm, the National Hurricane Center is your go-to source. During an active named storm, there will be multiple updates issued along with many different maps. These include the wind probability, the storm track cone, storm surge, tides, and many more.

This website is dedicated to covering Houston weather news and
forecasting with accuracy and without hype. Space City Weather
was founded in October 2015. This website isn't about making

### **Harris County Proposes Bond to Reduce Flooding**

Harris County Commissioners Court is having a bond election on August 25, 2018, for the Harris County Flood Control District. Registered voters in Harris County will be asked to vote on what could be \$2.5 billion in bonds for flood risk reduction projects throughout Harris County. The date of August 25 was selected because it is the one year anniversary of landfall for Hurricane Harvey, which brought devastating floods to Texas, including in Harris County. Early voting will start on August 8.

Harris County has begun scheduling a series of 23 community engagement meetings to solicit public input. Each of the 23 watersheds in Harris County will have a public meeting. As of press time, the date and place for the community meeting for Brays Bayou / Willow Waterhole Bayou watershed has not yet been announced.

The goal of the meetings is to describe some of the projects the county is proposing and to solicit input on which projects should be included. Flood Control officials also have created an interactive website detailing the status of more than 150 proposed and current projects throughout the county. For more information about the proposed projects, go to www.hcfcd.org/bondprogram.

Proposed projects may include: channel improvements and repairs, floodplain buyouts, and creation of greenspace and detention basins throughout the entire county. Some of these projects have been in the works for several years, but have been stalled by a lack of money. The needs are so great that even \$2.5 billion will not pay for all projects needed.

The Houston Chronicle on June 18, 2018, listed about \$30 million proposed for improvements to the "Fondren Diversion Channel", which is upstream of Westbury in the Brays Bayou and Willow Waterhole Bayou watersheds. The Fondren Diversion Channel overflows through Westbury when the water level gets too high.

# Top Questions and Answers about the Bond Proposal Q: Is this bond election a response to the Hurricane Harvey disaster?

A: The bond election project list developed by the Flood Control District includes projects that address documented flooding issues in each watershed – issues that come into play any time there is excessive rainfall in those watersheds. The list is not aimed only at the specific flooding that occurred during Harvey, but is aimed at making our entire community more resilient in the future. The bond funds would allow the Flood Control District to leverage the federal Harvey-related disaster funding that is on its way to Harris County.

#### Q: How much would the bonds cost property taxpayers?

A: The full cost of the bond will be phased in over several years, and will not impact property tax bills all at once. The Flood Control District plans to use these bonds over a 10- to 15-year period, as project timelines allow. Based on what could be \$2.5 billion in bonds and a likely borrowing schedule over approximately 15 years, the Harris County Budget Management Department estimates that the overall tax increase will be no more than 2-3 cents per \$100 of home valuation – meaning that most homeowners will see an increase of no more than 1.4 percent in their property tax. A homeowner with an over-65 or disabled exemption and a home worth \$200,000 or less would not pay any additional taxes for these bonds.

Q: How big is the total need in Harris County for flood risk reduction projects? A: Previous ballpark estimates of \$25 billion to achieve a 1% (100-year) level of service in Harris County suggest the magnitude of the flood risk issue. Additional funding from a bond would allow the Flood Control District to get more projects started and finished faster.

#### Q: How will projects in the bond proposal be selected and prioritized?

A: Harris County Commissioners Court directed Flood Control District staff to develop a list of projects that could be built with bond funding. This is not an exact list of projects that must be or will be built with bond proceeds. It represents a list of projects that would meet the goal of the bond election, which is to both assist with recovery after previous flooding events (including Harvey) and to make our county more resilient for the future.

High on the priority list are construction-ready projects with federal funding partners (such as the U.S. Army Corps of Engineers and the Federal Emergency Management Agency) that give the County "the most bang for its flood control buck." The list also includes locally funded projects in economically disadvantaged communities that may not meet the federal grant requirements, but where there is a substantial need for flood damage reduction work and a potential to serve the greatest number of residents. Consideration is also given to areas that have a lower level of current protection as compared to other areas in the county.

The Flood Control District list also includes potential flood risk reduction projects that will be developed with input from the County Engineer, the Harris County Community Services Department, and other governmental agencies in Harris County.



#### **Westbury Pesident Phyllis Frye Honored**

Longtime Westbury resident and former board member, Phyllis Frye, was honored on February 3rd at the American Bar Association Midyear Meeting in Vancouver, British Columbia, Canada. The ABA Commission on Sexual Orientation and Gender Identity honored University of Houston Law Center Alumna Phyllis Randolph Frye (Class of '81) with its 6th annual Stonewall Award for her long-time efforts on behalf of LGBT causes.

Named after the New York City Stonewall Inn police raid and riot of June 28, 1969, which was a turning point in the gay rights movement, the award recognizes lawyers who have considerably advanced lesbian, gay, bisexual and transgender individuals in the legal profession and successfully championed LGBT legal causes. According to its statement in announcing the award, "The ABA Commission on Sexual Orientation and Gender Identity leads the ABA's commitment to diversity, inclusion and full and equal participation by lesbian, gay, bisexual and transgender people in the ABA, the legal profession and society. Created in 2007, the commission seeks to secure equal treatment in the ABA, the legal profession and the justice system without regard to sexual orientation or gender identity."

"To be so honored by the ABA is also a reflection on the terrific education and

support that I received almost 40 years ago from the University of Houston Law Center," Frye said.

Frye, a pioneer in the transgender movement, became the nation's first openly transgender judge when she was appointed to the Houston Municipal Court bench in 2010. She has been honored numerous times for her legal and political activism on issues involving the transgender community.

In April of 2018 the Anti-Defamation League, reflecting on the 50th anniversary of the death of Dr. Martin Luther King Jr., paid tribute to Houstonians who carry on his legacy. The ADL's Houston 'Concert Against Hate' was an opportunity to recognize the honorees, while showcasing the many musicians and artists that make Houston a diverse melting pot of talent. Phyllis Frye was one of the 4 Civil Rights awards recipients.

Frye is an Eagle Scout and was a member of the Junior Reserve Officers' Training Corps. She graduated from Texas A&M University with a B.S. in civil engineering and an M.S. in mechanical engineering. She was honorably discharged from the U.S. Army in 1972, and transitioned in 1976 before earning an M.B.A. and J.D. from UH. She is a senior partner in the firm of Frye, Benavidez & O'Neil PLLC, where she devotes her practice exclusively



to taking transgender clients – both adults and minors – through the Texas courts to change the clients' names and genders on their legal documents.





#### Where is the "Dam" in Westbury?

The "dam" in the Willow Waterhole Bayou (WWB) is often mentioned in Crier articles when we discuss flooding. It cannot be seen from the road and is often envisioned incorrectly. The dam is an earthen structure that looks more like a big hill of grass. After the floods in 1975, the WCC Flood Action Committee had several proposals for an upcoming bond. One of them was to "install a barrier to the flow in the Willow Waterhole Bayou Channel immediately east of the Fondren Ditch to prevent floods in Westbury from rainstorms in Fort Bend County and Western Harris County". (Westbury Crier, August 1975, President John C. Severance).

Sometime in the early 1980s, the Willow Waterhole Bayou was dammed to separate Westbury from the Fondren water. This dam was funded thru a County bond election in 1982. The earthen dam is located on the edge of Westbury behind Beaudry/Braewick and Lattimer/Braewick homes. It is the "beginning" of the WWB. While the earthen structure holds water back during an average rain storm, during heavy rains such as Memorial Day and Harvey, the dam is overtopped with water flowing from the Braewick ditches and the other side of the WWB coming from the Fondren area and the Fondren Diversion Channel, which sit at a higher elevation than Westbury. The developers of the Fondren area tinkered mightily with the natural flow of WWB which once meandered lazily through Western Harris County and in Ft. Bend County. Now there are narrow channels with 90 degree turns upstream of Westbury and this small "dam" at the entrance of the WWB into Westbury.

The Westbury Civic Club strongly believes that the "dam" is outdated and in need of repairs. This structure needs maintenance and needs to be addressed. A study of the Willow Waterhole Bayou needs to be done so real answers and solutions to our flooding can really

#### Is your Alarm Permitted?

Did you know that City Ordinance requires burglar and panic alarm systems installed, in use, and/or monitored within the city limits to receive emergency response from the Houston Police Department to have a valid and current alarm permit? The alarm system owner is responsible for any false alarm fees and penalties for violation of this ordinance. Many residents may already have permitted alarm systems with the city while others may be operating illegally.

#### Why get a permit?

In addition to being compliant with the ordinance, the Houston Police Department (HPD) may refuse to respond to an alarm notification from a non-permitted burglar alarm system. Non-permitted locations receiving police response are subject to costly penalties currently ranging from \$114.03 to \$478.93 for each false alarm. A non-compliant location is a Class C misdemeanor and a ticket could be issued.

Additionally, residential burglar alarm permit holders receive their first 3 false burglar alarms and first false panic alarm free. Did you know last year 96% of all alarm calls HPD responded to were false? When HPD responds to false alarms, they are diverted from true emergencies, citywide response times increase, and limited city financial resources are strained. Proper alarm system installation and use combined with regular system maintenance can reduce false alarms.

#### Remodeling your home? Adding On? Do you know your deed restrictions?

Did you know that the Westbury Civic Club can look over your proposed plans for free before you start construction? We want to avoid deed restriction violations before they happen. Did you know that Westbury 2, Westbury 3, and Westbury 5 have a 25 foot rear setback for the main structure? Did you know that there is a minimum percentage of brick that must be on your home? Did you know that you can't build in front of your building line? We want to help you! We want you to find out about possible violations before it costs you money and time. Several homeowners in the past couple years have had to tear down and/or modify their construction due to deed restriction violations. The City of Houston does not review deed restrictions when issuing permits. They require a signed affidavit acknowledging that the plans comply with your deed restrictions. This holds YOU, the homeowner, accountable for knowing and complying with your deed restrictions. We are here to help you. All deed restrictions are available online at westburycrier.com.



We want to avoid deed restriction violations before they happen. Did you know that Westbury 2, Westbury 3, and Westbury 5 have a 25 foot rear setback for the main structure? Did you know that there is a minimum percentage of brick that must be on your home? Did you know that you can't build in front of your building line? We want to help you! We want you to find out about possible violations before it costs you money and time. Several homeowners in the past couple years have had to tear down and/or modify their construction due to deed restriction violations. The City of Houston does not review deed restrictions when issuing permits. They require a signed affidavit acknowledging that the plans comply with your deed restrictions. This holds YOU, the homeowner, accountable for knowing and complying with your deed restrictions. We are here to help you. All deed restrictions are available online at www.westburycrier.com. furry pets such as small cats and dogs.






#### **ALLIGATORS IN THE BAYOU**


### **Turtle Crossing on Mullins**

#### **Summer Yard Care**

Summer is upon us and our grass is really growing. Let's talk mowing.

Sweep or Blow? We receive regular complaints about lawn services blowing yard clippings into the street. Where do they end up? In our storm sewers. A heavy rain will flush such lawn debris down the storm sewers, plugging them bit by bit, impairing their ability to move the water out of Westbury. The end result can be street flooding. I suspect we've all seen enough street flooding by now. If you employ a lawn service, please tell them DO NOT BLOW YOUR LAWN CLIP-PINGS OR LEAVES into the street.

How tall should your grass be? Grass over 9 inches is in violation of city ordinance and should be reported to 311. Remember to increase the height setting on your lawn mower as the summer days get hotter lawns should not be cut too short.

**Can I park on my grass?** It is a violation of city ordinance to park any vehicle on the front or side yard of a residential property in Westbury.

#### **Mosquito Control**


are out full force! Mosquitoes are not only annoying but they can carry dangerous illnesses. The best way to keep down the number of mosquitos is to not let them breed.

Mosquitos can breed anywhere that water is left to stand or collect. If you look in the standing water, you may see little wiggling things. Those are baby mosquitoes (larvae). Some examples of where water may be left standing include: pet water bowls, bird baths, low puddle areas, saggy gutters, and plant container saucers. What can each of us do to reduce the numbers of mosquitos?

- Tip over all the water collectors in your yard and leave them turned over to discourage mosquitoes
- Don't allow standing water in saucers under a pot.
- Rinse and refresh bird baths and pet water bowls daily.
- If you collect rainwater to water your plants, be sure the container has a good screen cover to keep the mosquitos out.
- If you have a decorative pond in your backyard, check it for mosquito larvae. Small fish called Gambusia (Mosquito Fish) can be added to eat the mosquito larvae.
- Keep gutters in good repair.
- Get rid of old tires.



### Park Smart Meeting at Willow Waterhole

As we've reported previously, Harris County Precinct One County
Commissioner Rodney Ellis has been conducting an evaluation of all parks in Precinct One. This is being done as a yearlong project called "Park Smart Precinct One" with assistance from The Trust for Public Land (a national nonprofit which helps communities plan, fund, protect, and create parks and public land) and Asakura Robinson (a local planning, urban design, and landscape architecture firm). There have been multiple workshops soliciting input from the public.

The Willow Waterhole Greenspace Conservancy (WWGC) and Precinct One scheduled a meeting on May 31 at The Gathering Place to discuss the specific needs of this 300 acre park, which overlays stormwater detention lakes owned by Harris County. The venue was packed with supporters of this unique site to hear more about the Willow Waterhole wants and needs.

Howard Sacks, past president of the WWGC and current president of the Levitt Pavilion Houston Board, hosted the event and gave a brief synopsis of the WWGC. Becky Edmondson, President of the WCC, welcomed everyone to the Westbury neighborhood and explained how her definition of the Westbury community had changed over time. In the beginning, she saw Westbury simply as 5000 single-family homes, but with the creation of the Westbury Super Neighborhood, her definition of Westbury expanded to include the 3500 multi-family units, the schools, the churches, the parks, and the retail spaces. She saw how issues like flooding and crime brought the

surrounding Super Neighborhoods together with common issues. Westbury is not an insular neighborhood; it is an inclusive neighborhood.

Skip Reeder talked about how diverse our community is: that every major religion is represented in the Brays Oak Management District (BOMD); and that almost every country in Central America, South America, Asia, Europe, and Africa were represented in our community. He spoke of the diversity of ethnicity, language, faith, and economics. He likened the Willow Waterhole to Central Park. In 1853, New York City set aside 750 acres to improve public health and contribute greatly to the formation of a civil society made up of so many immigrants and freed slaves.

Accentuating the true diversity of the community surrounding the Willow Waterhole Greenway, statements were presented by nearby entities: the convent of St. Catherine's Vietnamese Dominican Sisters, the Westbury Place nursing home, the Gathering Place,

Westbury High School, and Westbury Little League. Ralph Reiger, Eugene Sirls, and Bill Burhans made presentations about accessibility and basic needs of the park. Eugene Sirls, a Westbury resident and WCC board member representing Neighborhoods to Trails Southwest, described trails proposed to connect people to places. Ralph Reiger discussed paving, parking, and land acquisition needs. Bill Burhans, a Westbury resident and Conservation Director for the WWGC spoke about security issues and the need for restrooms.

Afterwards, Bill Burhans said: "I was so pleased with the presentation, it accomplished the objective of providing Precinct One with information it did not have in regard to the population served by the Greenway, its most needed projects, and security issues. The presenters at the meeting were very representative of the community and did a great job in providing data and examples to support a unified message. We are shovel ready, just need some funding assistance."

### **WCG Tomato Tasting Success!**

The 5th annual Tomato Tasting was a huge success. Not only do the WCG gardeners know how to grow tomatoes, they know how to put on a successful event! New WCG President, Betsy Longoria, and Debbie Gordon, WCG Event Coordinator, along with 18 volunteers hosted close to 80 participants for the tasting.

The participants had the pleasure of tasting 30 varieties of tomatoes grown by Westbury gardeners. Three tables were arranged with plates of tomatoes to taste and a score card provided. There were four categories: Slicers, Saladettes, Paste and Cherry. There were some old time favorites and some new varieties this year. Tasters got to sample 11 different slicer tomatoes, 3 saladettes, 1 plum/paste tomato and 8 cherries. The crowd then voted on their favorites.

The tomato voted favorite slicer was Black Krim. Second place in the slicer category was Cherokee Purple. The black/purple tomatoes have such an interesting and complex flavor. The favorite salad tomato was Juliet, a prolific variety with great flavor this year. The paste tomato was San Marzano, the classic Italian variety. In the cherry category, a new red cherry called Braveheart took top honors. In second place was Sun Gold, which is a WCG favorite that always places at or near the top. Sugary and Sweet Chelsea were tied for third in the cherry category.

Many people feel that they can't grow tomatoes, but the Westbury Community Gardeners prove that it can be done! Look for opportunities to learn how to garden and become a successful gardener in your own backyard. It's both rewarding and tasty!

#### **Summer Gardening 101**

It's too late to plant tomatoes, but there are other plants that thrive in the heat. Plant vegetables that like heat such as okra, eggplant, peppers, sweet potatoes, and heat loving beans, edamame (Midori Giant), and southern peas (zipper cream). Beans and peas make nitro-

gen and so they need little fertilizer, and they "prepare" the soil for the next crop.

Be sure to mulch properly. Use alfalfa hay, pine needles or leaves and evenly cover with 2 inches of material.

Watering: Keep newly planted seeds

and plants moist, which might mean watering daily or more often. For established plants, test soil and only water when soil is dry one inch below the surface and then water evenly and thoroughly.



Amelia Goldberg, member of the Westbury Community Garden, has had a very productive year from her one plot at the garden. This picture shows tomatoes canned (24 pints) in one day, plus those waiting to be canned. She previously had canned 56 pints in the last couple of weeks. That totals 80 pints so far of tomatoes and tomato sauce.

Amelia says "I picked some of the tomatoes still green and roasted them with onions, garlic and red pepper flakes to make a green sauce

that we love. During the winter, we love chili, vegetable soup and pasta with tomato sauce. I will have plenty of good, organic tomatoes for those dishes, all from my plot in the community garden."
