Purpose:

The intent of this policy is to explain when the Board of the Westbury Civic Club is allowed to convene in Executive Session during regular or special meetings.

Policy:

The Westbury Civic Club follows regulations in the Texas Property Code (TPC) regarding Open Meetings. All regular and special Board meetings will be open to the public except for those circumstances where the TPC allows part of the meeting to be held in private Executive Session. After the board reconvenes in the open public meeting, then the subject of the private session and any decision will be summarized in general terms for the meeting minutes. The TPC allows these topics to be discussed in private Executive Session.

- personnel
- pending or threatened litigation
- contract negotiations
- enforcement actions
- confidential communications with the property owners' association's attorney
- matters involving the invasion of privacy of individual owners
- matters that are to remain confidential by request of the affected parties and agreement of the board.

This Policy is effective upon recordation in the Public Records of Harris County, and supersedes any policy regarding **Open Meetings** which may have previously been in effect. Except as affected by State Law and/or by this Policy, all other provisions contained in the Declarations or any other dedicatory instruments of the Association shall remain in full force and effect.
