KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, heretofore, by instrument dated March 1, 1955, Chimney Rock Co., the then owner of the property affected thereby did file certain restrictions as to lots located in WESTBURY, SECTION NC 2, Harris County, Texas, a plat of which said subdivision has been Tiled for record under File No. 1387702, Map Records of Harris County, Texas, which said restrictions have been duly recorded in the Records of Harris County, Texas, under County Clerk's File No. 1391145 and, as so recorded, are specifically made a part hereof for all purposes; and

WHEREAS, Chimney Rock Co. has heretofore conveyed to Bellfort Co. all lots in said WESTBURY SECTION NO. 2, to be affected hereby; and the said Bellfort Co. has heretofore conveyed to Roy F. Wynn Lots One (1) and Two (2) in Block Twenty Two (22) of said WESTBURY SECTION NO. 2, and same and except as to said two lots so conveyed and now owned by the said Roy F. Wynn, all of the remaining lots in WESTBURY SECTION NO. 2 to be affected hereby are owned by Bellfort Co.

NOW, THEREFORE, we, BELLFORT CO. and ROY F. WYNN, do hereby agrouthat the restrictions aforomentioned as heretofore filed and recorded by Chimney Rock Co. shall be AMENDED AND MODIFIED to the same extent as if placed therein when originally written and recorded, by the addition thereto of the following:

No main residential building shall be located nearer than 25 feet to the rear lot line, to the end of and with the purpose that the minimum distance from main building to rear lot line shall be 25 feet and the sum of the side yards for dwellings two stories in height shall be not less than 12 feet.

Nothing in the foregoing shall be so construed as to alter or change the restrictions, as originally recorded, inserar as the sameaffects and apply to Block Twenty Ono (21) in WESTBURY SECTION NO. 2; and nothing in the foregoing shall be so construed as to cause the restrictions originally filed and herewith amended to cover, attach and apply to that certain property identificant the plat of Westbury Section No. 2 as "Reserve C Unrestricted".

Except as provided herein, the said original restrictions filed in the Records of Harris County, Texas, under County Clerk's File No. 139105 are unchanged and shall remain in full force and effect.
